What is the export procedure in Bosnia & Herzegovina?

The goods whose circulation is prohibited in Bosnia and Herzegovina cannot be imported or temporarily imported. The export procedure allows BiH goods to leave the BiH customs area. Export includes implementation of export operations and procedures including trade policy measures, and if prescribed, collection of export duties as well.

What are the import regulations in Bosnia & Herzegovina?

Sanitary, veterinary, phytopathological, ecological and quality controls of the imported goods are required in accordance with specific regulations. The goods whose circulation is prohibited in Bosnia and Herzegovina cannot be imported or temporarily imported. The export procedure allows BiH goods to leave the BiH customs area.

How do customs procedures work in Bosnia & Herzegovina?

When engaging in the import and export of goods in Bosnia and Herzegovina, it is crucial to understand the established customs procedures. These procedures ensure compliance with national regulations and facilitate the smooth transit of merchandise across borders.

How are import duties paid in Bosnia & Herzegovina?

For all other shipments, import customs clearance is carried out and import duties are paid via customs postal declaration using the customs rate prescribed by the Customs Tariff of Bosnia and Herzegovina, i.e. 5%, 10%, or 15%, with a single VAT rate of 17%.
