What is happening in Spain's lithium-ion battery market?

The Spain lithium-ion battery market is entering a new stage of rapid development. The Zaragoza plant of global automotive giant Stellantis is partnering with CATL, the world's largest EV battery manufacturer, to expand electric vehicle production and build a large-scale battery manufacturing facility in Spain.

Will CATL and stellantis reshape Europe's Lithium-ion battery market?

If finalized, the joint venture between CATL and Stellantis in Spain will reshape the Spain lithium-ion battery market, further integrating the European EV ecosystem. For CATL, this would add another overseas plant to its growing global footprint.

Will Spain be a leader in Europe's Lithium-ion battery industry?

Although Stellantis has not yet made a final decision, the Spanish government is actively pushing forward the project, aiming to anchor Spain as a strategic leader in the Europe lithium-ion battery industry. A Stellantis spokesperson confirmed that the project remains subject to regulatory approval but welcomed the government's support. 2.

How much money will Spain spend on stellantis' battery plant?

On October 8, Spain's Minister of Industry and Tourism, Jordi Hereu, announced that the government has allocated €133 million in subsidies to support Stellantis' proposed battery manufacturing plant near Zaragoza. The project, developed in partnership with CATL, is expected to attract nearly €2.5 billion (19.3 billion yuan) in investment.
