# **VAT on solar container battery sales**

Do I have to pay 0% VAT on solar & energy storage?

Solar Energy UK recommendations to support the uptake of residential solar and energy storage All solar and energy storage installations, including maintenance to existing sites, should be subject to 0% VAT. This should include residential energy storage when installed as a standalone measure.

When will the VAT charge be removed for battery energy storage systems?

As of 1 February 2024, the UK government has removed the VAT charge for domestic battery energy storage systems (BESS) under any circumstance. The policy change, initially announced in December 2023, followed a lengthy campaign by both Solar Energy UK and parliamentarians to include retrofitted BESS in the 20% tax exemption.

What is the new VAT exemption for domestic battery storage installations?

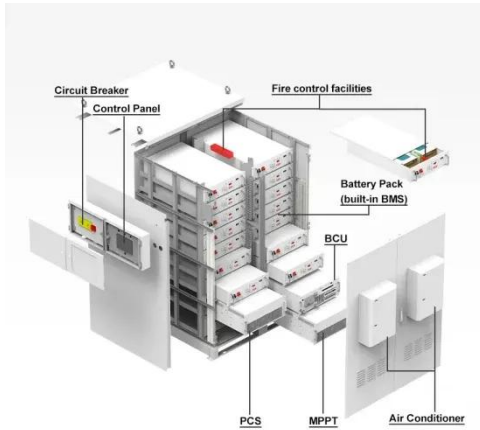
The recent VAT exemption for domestic battery storage installations is a significant development for the UK's renewable energy sector. Announced by the UK government, this policy change, effective from Febru, removes the 20% Value Added Tax (VAT) on domestic battery energy storage systems (BESS).

How does VAT affect solar batteries?

The financial impact of the VAT exemption is substantial. Previously, the cost of installing a battery storage system included a 20% VAT, significantly increasing the how much solar batteries cost. For instance, a battery storage system costing £5,000 would have an additional £1,000 added in VAT.
